

## BMCA Annual Dues, Benefits, Joining and Renewal

Annual Dues for the term of the contract are due in full by November 10, 2023 and will be as follows:

- In Town businesses purchasing 10 or less employee passes: \$480 Annual Fee
- In Town businesses purchasing 10-15 employee passes: \$580 Annual Fee
- In Town businesses purchasing 15-20 employee passes: \$680 Annual Fee

**Member Benefits** apply to all businesses, no matter whether their peak business activity occurs in the summer or the winter. We require that the employees selected work at least 32 hours per week either during the summer or the winter months. Benefits for 2023/2024 Season will be as follows:

- Continued free advertising on the S.N.O.W. busses. To participate in SNOW bus advertising, submit a pdf ad for your business.
- Continued voting representation on BMCA Board
- Website link from the bigmtncommercial.org website
- 2 Season Passes @ \$575, and up to 20 Season Passes available through 11/17/2023 @ \$739 for employees.
  - Season Passes can be given to anyone but are not transferable and cannot be changed once committed.
  - All Whitefish Mountain Resort pass policies and perks apply.
  - Season Passes <u>must</u> be purchased through WMR by November 17,2023at 5:00 pm. List of Eligible Employees due by November 10, 2023 at 5:00pm. There are no refunds for missed deadlines.
  - Once BMCA has received a signed agreement for your business, a copy will be forwarded to WMR verifying membership in program.
  - Each business must provide a **listof employeesto theticketofficeatWhitefish Mountain Resort** (after BMCA has received your application and fee) who are eligible to purchase Season Passes and at which rate they will be purchasing them. This form will be provided to your business once eligibility is confirmed by the BMCA.
  - Our primary source of communication will be e-mail.





- Employees must be on employers list in order to purchase \$739 Season Passes between October 1 and November 17, 2023.
- Pass holder need not be present to purchase Season Passes, but each pass purchased must have a name attached, as the employees will be asked to show identification upon picking up their passes. The WMR Information center will contact you regarding pass purchases
- If you have bought a pass during the early bird promotion, you may receive a refund providing your BMCA member pass is purchased by the deadlineof November 17,2023
   by5:00pm. Refunds for early price reimbursement must be requested by contacting Denise at the WMR ticket office.

# THE PARTIES AGREE AS FOLLOWS:

### Membership Obligations

- Member agrees to a membership period that expires on October 31, 2024.
- In Town businesses purchasing 10 or less employee passes: \$480 Annual Fee
- In Town businesses purchasing 10-14 employee passes: \$580 Annual Fee
- In Town businesses purchasing 15-20 employee passes: \$680 Annual Fee

- Member agrees to pay the annual fee to the Association by the 10th day of November, 2023.

- Member agrees to provide proof of employee roster showing that each employee works a minimum of 32 hours per week during the summer or winter months.

- If a BMCA Business member employee quits/is released/ or otherwise is no longer employed by the BMCA Business member, it is the responsibility of the BMCA business member to set policy for their employees if an employee quits/is released or otherwise is no longer employed.

# **BMCA Obligations**

- BMCA agrees to provide the business two "Owner Season Passes" for \$575 per pass for the season of 2023/2024
- BMCA agrees to provide the discounted Season Passes rates of \$739 for employees of the business, as long as the pass is purchased by November 17, 2023 by 5:00 p.m.
- BMCA agrees to provide the business with free advertising on the interior of the SNOW buses; however, the cost of production of the ad is the responsibility of the business.
- BMCA agrees to add a link to its member page of the bigmtncommercial.org website.
